# COMMON WAYS TO MAKE A LEGACY GIFT

#### **Bequest in Your Will or Trust**

- Leave a percentage of your estate, a specific amount, or the remainder
- Your estate may receive a tax deduction
- Easy to update with a simple codicil or trust amendment
- Sample bequest language
  - "I give, devise and bequeath (state a percentage or dollar amount, or specific property or other asset) to the Savannah Music Festival. Inc."

# Retirement Plan or IRA Beneficiary Designation

- Name SMF as a beneficiary of a percentage, specific amount, or remainder
- Retirement plan distributions to charity are tax-free
- Contact your plan administrator for the beneficiary form





## OTHER LEGACY GIVING OPTIONS

## **Appreciated Securities**

- No capital gains tax
- Tax deduction for fair market value

#### Life Insurance Policies

- Donate a new or existing policy
- Tax deduction for policy value
- If SMF is the owner and beneficiary, your premium payments become taxdeductible gifts

## IRA Required Minimum Distribution (RMD)

- Individuals aged 70½+ can donate up to \$100,000 tax-free each year
- Amount does not count as taxable income
- Must transfer directly from IRA custodian to charity

#### **Charitable Remainder Trust**

- Provides income to you or loved ones
- Pro-rated tax deduction now
- Remainder becomes your legacy gift

#### **Charitable Lead Trust**

- Supports both family and charity
- Uses income-producing assets
- Reduces gift or estate taxes
